# **Loose Ends Hold Up Adjournment**

Water issues came late and unexpected to the Idaho Legislature this session. CAMP proved to be unexpectedly controversial in its adoption. After hitting some rough water, it appears to be back on track. The Senate postponed its hearing from Monday, April 6, to Wednesday, April 8th to accommodate the funeral of Senator Malepeai's wife. The House of Representatives suspended rules to adopt H0264 on Friday, March 27th.

Swan Falls II, a package of 3 bills, is being fast-tracked through the legislature. S1168, relating to ground water recharge, ran into some minor complications. The Idaho Water Users Association proposed an amendment to the bill that already existed in code. S1168 was replaced with S1185 and is now back on the Senate 3rd reading calendar along with the other two bills, S1167 and S1169. The governor reportedly supports the legislation and the agreement.

The agreement consists of four parts: a framework, a negotiated settlement between the intervener parties in the SRBA, the three pieces of legislation currently before the legislature, and a Memorandum of Understanding between Idaho Power and the state to address existing issues. Over the 25 years since the original agreement was developed, there have been many issues that have remained unresolved. Under the terms of the newly proposed MOU, these issues will be addressed so that the state and Idaho Power can finalize the original Swan Falls Agreement and move forward.

The legislature was projecting that the session could adjourn sine die on or around April 17th. Losing a day to respect Senator Malepeai's loss and possibly taking Good Friday off along with unresolved finance issues probably will extend the session out into the week of April 20th. Most committee's have adjourned subject to the call of the chair, JFAC included.
